On 5 January 2018, the Company announced that it had raised \$4,500,000 from an issue of convertible notes, earning interest at 8% per annum with an exercise price of \$16.71 expiring on or before 31 December 2018 pursuant to agreements dated 29 December 2017. As at 31 December only \$1,500,000 of the \$4,500,000 had been received in the bank account and the remaining amount of \$3,000,000 was received on 4 January 2018. 4F Investments Pty Limited, a company controlled by the Chairman, Mr Fred Bart has agreed to take up an additional \$500,000 of these convertible notes subject to approval by shareholders at the next Annual General Meeting to be held prior on 7 May 2018.
